



# Chorleywood Controlled Parking Zone GS, ST & TX

## Chorleywood GS, ST, TX Permit Parking Zone

The Chorleywood Permit Parking Zone helps to prioritise parking for people living locally and to improve safety and traffic flow in the roads shown on the map overleaf.

**Parking bays are provided for anyone with a permit to park between 7am and 2pm Monday to Friday in zone GS.**

**9am – 5pm Monday to Friday in zone ST**

Shoppers and other visitors can park in the short-stay bays around the area and in the local car parks. Long-stay parking is available in Council car parks.

During the restricted hours, any vehicle parked within the zone must have a valid permit. Parking across dropped kerbs within permit bays is unlawful (except your own driveway if a valid permit has been obtained).

### Resident Permits

Permits confirm that the vehicle has a valid reason to be parked in the Zone. A permit can be used only within the zone for which it was issued. Residents of addresses in the following streets will be able to apply for an annual

permit for a vehicle they own, up to 2 permits per address.

- Green Street (GS)
- Station Approach (ST)

### What do permits cost?

£75 for the first permit in a household and £138 for the second. First permits are free where there is a holder of a Blue Badge in the household. A copy of the Blue Badge must be supplied when applying??

### Visitor Vouchers

Each household is eligible for visitor vouchers, which come in books of 10, at a cost of £15 per book.

### Special permits

In exceptional circumstances, special permits may be offered, for example where severely disabled or older residents rely on family carers who need to visit to provide essential care.

In all cases applications must be supported by evidence and a solely at the Councils discretion.

### What do I need when I apply?

You will need to prove that you live at an address in the Zone and that you own or use the vehicle. The size of your vehicle must not exceed 5.25m long or 2.3m high.

## Courtesy vehicles

If your vehicle with a registered permit has to be temporarily replaced with a courtesy vehicle for such events as garage repairs, you will require a temporary permit. Please contact parking services by email at [trdc.parkingservices@hertsmere.gov.uk](mailto:trdc.parkingservices@hertsmere.gov.uk) where a member of the parking team will provide you with a temporary virtual permit. This only applies to residential permits. Supporting documentation may be requested.

## Changes of vehicles

There is no charge for the first change of vehicle. In order to change your vehicle you will need to do this through your own permit smarti account under the vehicles section.

If you require assistance please contact parking services where a knowledgeable Officer will assist you.

## Refunds

If you leave the area or dispose of your vehicle you can obtain a pro rata refund based on the full number of months remaining on your permit. Please be advised permits with less than three full months will not be eligible for a refund.

All refunds are subject to a £7 administration fee which is deducted from the refund total. Lost business permits will not be replaced and a new application will need to be made.

## Renewing your permit

As a Matter of courtesy Parking Services send out automatic renewal reminders via your online permit account, at least 21 days before it is due to expire. It remains the responsibility of the permit holder to ensure their permit is renewed upon its expiry each year and would be advised to make a note of this date.
