THE THREE RIVERS DISTRICT COUNCIL (ON-STREET PARKING PLACES, LOADING PLACES AND WAITING, LOADING AND STOPPING RESTRICTIONS) (NO.2) ORDER 2025 (GOSFORTH LANE, HENBURY WAY, OTLEY WAY AND TURNBERRY COURT, SOUTH OXHEY) (VARIATION) ORDER No. 5 2025

Three Rivers District Council, pursuant to arrangements made under Section 19 Local Government Act 2000 and Local Authorities (Arrangements for the Discharge of Functions) (England) Regulations 2000 with the Hertfordshire County Council, and in exercise of powers conferred on that County under sections 1, 2, 3, 4, 5, 32, 35, 36, 39, 45, 46 and 49 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004 and of all other enabling powers, and after consultation with the Chief Officers of Police in accordance with Part III of Schedule 9 to the aforementioned 1984 Act, makes the following Order:

- 1. The Three Rivers District Council (On-Street Parking Places, Loading Places and Waiting, Loading and Stopping Restrictions) (No.2) Order 2025 ("the 2025 Order") shall be amended with the sealed plan(s) specified in the First Schedule to this Order.
- 2. The effect of this Order is to introduce the restrictions set out in Schedules 2 and 3 to this Order.
- 3. The properties listed in the Fourth Schedule to this Order will be inserted into Schedule 2 of the 2025 Order and will therefore become eligible for Parking Zone Permits for Parking Zone 'GL'.
- 4. The permit charges listed in the Fifth Schedule to this Order will be inserted into Schedule 3 2(a) and 4(a) (i) of the 2025 Order.
- 5. The parking zone GL shall in included in Article 32 (1) of the 2025 Order for application and grant or issue of residents' visitor's permits.
- 6. This Order shall come into operation on XX day of XXXXX 2025 and may be sited as The Three Rivers District Council (On-Street Parking Places, Loading Places and Waiting, Loading and Stopping Restrictions) (No.2) Order 2025 (Gosforth Lane, Henbury Way, Otley Way and Turnberry Court, South Oxhey) (Variation) Order No.5 2025, hereinafter referred to as 'this Order';
- 7. The interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
