NOTICE IS HEREBY GIVEN that the THREE RIVERS DISTRICT COUNCIL in exercise of the powers under Sections 32 and 35 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, and the provisions of the Traffic Management Act 2004 and of all other enabling powers and with the consent of the Hertfordshire County Council in accordance with Section 19 of the Local Government Act 2000 has made the above named Order. The Order shall come into operation on 3 November 2025.

The general effect of the Order would be to introduce short stay, long stay and business parking in the Ferry car park, Lower Road WD3 5LB and to include in the original Order the Talbot Road car park WD3 1HE, where residents and business parking is allowed.

## THE THREE RIVERS DISTRICT COUNCIL (OFF-STREET PARKING PLACES) (NO.1) ORDER 2024 (AMENDMENT No.1) ORDER 2025

Three Rivers District Council proposes to make the above named Order to enable it to offer short and long stay parking in Ferry Car Park, and business and resident parking in Talbot Road Car Park.

This will allow the council to encourage the use of the off-street parking places for short stay, long stay and business parking at those times and reduce the demand for on-street parking in line with the objectives of regulating parking places.

- 2. The provisions of the THE THREE RIVERS DISTRICT COUNCIL (OFF-STREET PARKING PLACES) (NO. 1) ORDER 2024 as amended are hereby amended in accordance with Articles 3 and 4 of this Order.
- 3. Within Schedule 2, item no.6 of the 2024 Order, The Ferry Car Park will be amended as indicated in Schedule 1 of this Order.
- 4. THE THREE RIVERS DISTRICT COUNCIL (OFF-STREET PARKING PLACES) (NO. 1) ORDER 2024 is hereby amended by the inclusion of items in Schedule 2 to this Order.
- 5. The interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- 6. The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act of 1984 or by any enactment.
